MANIKESWARI CHHATAR JATRA BHAWANIPATNA ODISHA MATTER WHERE LAKHS OF ANIMALS AND BIRDS ARE SLAUGHTERED ON PUBLIC ROAD AND PUBLIC VIEW AND THE AOR GAVE A SAFE PASSAGE TO CONTINUE THE SLAUGHTER ON THE INSTRUCTION OF GOVT OF ODISHA BY BRINGING STAY FRAUDULENTLY FROM SUPREME COURT

Respected Sir

With due respect I want to bring to your kind notice that through my email dated 24 10 2021 I had requested you to take suo motu cognizance in the above said matter.

I do not know whether my letters and email are placed before you or not.

The concerned AOR OF ODISHA GOVT KIRAN KUMAR PATRA had filed SLP 21329 OF 2020 IN SUPREME COURT AGAINST GOVT OF ODISHA TO GET A STAY ON ORISSA HIGH COURT ORDER IN WPC PIL 19827 OF 2017 by suppressing the fact that he is the AOR OF GOVT OF ODISHA and this is a serious professional misconduct of an AOR IN SUPREME COURT where he misguided the then CJI consisting of a bench of three judges and was successful to get a stay on a historical judgement of ORISSA HIGH COURT ORDER IN WPC PIL 19827 OF 2017 pronounced by HON'BLE JUSTICE ORISSA HIGH COURT SMT SANJU PANDA (NOW RETIRED) AND HON'BLE JUSTICE ORISSA HIGH COURT SHRI SANGRAM KUMAR SAHOO.

I brought this fact with documentary evidences to the knowledge of the REGISTRY OF SUPREME COURT, BAR COUNCIL OF INDIA, SCAORA, SCBA, OSBC CUTTACK, ATTORNEY GENERAL INDIA, ADVOCATE GENERAL ODISHA, REGISTRAR GENERAL ORISSA HIGH COURT CUTTACK, OSLSA CUTTACK and other prominent advocates of Supreme Court to take cognizance of the professional misconduct as well as the criminal intention and action of both GOVT OF ODISHA AND ITS AOR KIRAN KUMAR PATRA.

BOTH GOVT OF ODISHA AND ITS AOR KIRAN KUMAR PATRA have tried to play with the dignity and credibility of Supreme Court with the direct help of REGISTRY OF SUPREME COURT and indirect support of the above mentioned institutions which is proved from their willful inaction and pin drop silence from every quarter since 2021 till date.

Under the circumstances when SUPREME COURT imposes heavy fine in lakhs even on premium advocates of Supreme Court for any comment on judiciary then I request the Supreme Court to impose fine in crores on Govt of Odisha as well as AOR KIRAN KUMAR PATRA and cancel his license atleast for ten years.

It is also requested to take appropriate legal action against the above mentioned institutions for their passive support as they have not come forward to save the dignity and credibility of Supreme Court and above all the system of registry of Supreme Court should be changed and overhauled as in this particular case they are the prime accused of backstabbing Supreme Court as they have received my emails, letters addressed to you and to them but they did not bring this matter to your notice and

they repeated the mistake again and again by taking up the case in single judge court in Supreme Court.

I think the time has come that there should be a direct link through email to all the Hon'ble Judges of the Supreme Court and all High Courts without any intervention of any registry.

The registry of all the courts should be under surveillance under a retired judge as it is the breeding ground of suppression of facts as well as listing and delisting of cases and maintenance of records.
