SUBJECT-MY RTI DATED 08 02 2023 TO CHAIRMAN BCI TO PROVIDE COPY OF ATR ON THE COMPLAINT AGAINST AOR IN SUPREME COURT KIRAN KUMAR PATRA FOR SUPPRESSION OF FACTS THAT HE IS AOR OF GOVT OF ODISHA IN SUPREME COURT IN SLP 21329 OF 2020 BEFORE FIVE JUDGES OF SUPREME COURT INCLUDING CJI

Sir

Please refer to your letter no 186 of 2023 dated 25 03 2023 to CPIO OSBC CUTTACK with a copy to me stating that my RTI was transferred to CPIO OSBC CUTTACK as the said advocate KIRAN KUMAR PATRA is enrolled with OSBC and I had some grievances against him.

It is pertinent to mention that although six months have passed there is not a single reply of the same from CPIO OSBC CUTTACK and from this attitude and behavior of OSBC it can be inferred that OSBC gives a damn to BCI, CIC, OIC and RTI ACT.

It is pertinent to mention that the complaint was made against AOR OF GOVT OF ODISHA IN SUPREME COURT KIRAN KUMAR PATRA for the reason mentioned above in the subject and in my FORM A to the Chairman BCI as he is not an ordinary advocate but an AOR and he has committed the crime in Supreme Court and so it is in your domain.

It is ridiculous that you have not taken a single action against him and instead of that you have painted my complaint as my personal grievance and sent it to OSBC whereas AOR OF GOVT OF ODISHA IN SUPREME COURT KIRAN KUMAR PATRA has committed a heinous crime against the top judiciary ie SC by fooling the Hon'ble Judges, done impersonation, suppressed the fact in collusion with registry of SC.

This issue has been brought to the notice of the concerned authorities including you, prominent lawyers of SC etc repeatedly for last three years but DUE TO CONFLICT OF INTEREST AND THE DEPENDENCE OF LAWYERS ON THE REGISTRY FOR LISTING THEIR CASES NOT A SINGLE RESPONSE IS MADE IN THIS CONTEXT AND FROM THIS IT IS OBVIOUS THAT WILLFULLY THIS NEXUS OF AORS WITH REGISTRY IS ACCEPTABLE BY THE LEGAL FRATERNITY.

As there is no direct communication between the common man and the judges and everything including email, speed post are routed through the registry; the message and the complaint of an ordinary person does not reach the judges.

It is an issue of constitutional failure and it can never be sorted out by the advocates against their fellow advocates who send them to power for five years in the Bar Council Of India and State Bar Council.

Under the circumstances due to willful inaction of BCI, REGISTRY OF SUPREME COURT, OSBC, SBCA, SCAORA who encouraged AOR OF GOVT OF ODISHA IN SUPREME COURT KIRAN KUMAR PATRA to play with SC judges and dared to go ahead without confession I am forced to send this email to the

top political parties to have a debate in the parliament during the session for amendment of Advocates Act.
