MISCONDUCT OF KIRAN KUMAR PATRA AOR OF ODISHA GOVT IN SUPREME COURT IN COLLUSION WITH REGISTRY OF SUPREME COURT IN SLP (CIVIL) DIARY NO.21329 OF 2020 ARISING OUT OF ORISSA HIGH COURT ORDER IN WP (C) 19827 OF 2017 WHICH IS A CRIME AGAINST JUDICIARY AND CONSTITUTION OF INDIA WHERE THE STATE GOVT ACTS AS AN AGENT TO MAKE ITS OWN HIGH COURT'S ORDER INFRUCTUOUS IN SC BY ITS OWN AORs IN FRAUDULENT MANNER

AOR Shovan Mishra of Govt of Odisha in SC who is appearing on behalf of CHIEF SECRETARY ODISHA, DGP ODISHA, DIG SWR KORAPUT, DM KALAHANDI and SP KALAHANDI is fully aware of the fact that AOR of Govt of Odisha in SC Kiran Kumar Patra has done professional misconduct by filing the SLP AGAINST GOVT OF ODISHA and committed the crime of impersonation and perjury before Hon'ble CJI and two other Justices to bring a fraudulent stay but AOR Shovan Mishra of Govt of Odisha in SC did not object to it and did not bring it to the notice of the court and so he is equally involved in this process of misleading judiciary for appeasing their political masters on whose mercy they earn tons of money.

Most respectfully I want to inform the authorities that after receiving several numbers of emails from me and enquiry initiated as per the email from recordroom@sci.nic.in dated Sep 16, 2025 to SUPREME COURT REGISTRY sec.xia@sci.nic.in and BAR COUNCIL OF INDIA NEW DELHI dcdepartment.bci@gmail.com no action has been taken in this matter only because of two AORs of Govt of Odisha in SC Kiran Kumar Patra and Shovan Mishra and registry of SC are involved in this controversial and fraudulent stay brought on OHC ORDER as all these three parties are fully aware of the fact that they are committing professional misconduct.

It is pertinent to mention that the Government of Odisha is sitting on the matter of misconduct of their AOR in Supreme Court since 2020 and it is because of their direct involvement to bring a

fraudulent stay on OHC ORDER in a PIL by using their influence and contact in the registry of Supreme Court for their vote bank politics to retain power in western Odisha and it cannot be wrong to say that western Odisha is a hub of brutality and cruelty to animals in public view in public places to show their power in Sulia Jatra of Bolangir, Chattar Jatra in Kalahandi and many more.

As both Government of Odisha and registry of Supreme Court are the necessary parties and directly involved in the process of committing crime against highest judiciary of the country I think time has come to upload the matter IN SOCIAL MEDIA AS ALL THE CHANNELS LIKE SPEED POST AND EMAIL TO REACH THE HON'BLE JUDGES ARE HIJACKED BY THE CONCERNED REGISTRIES OF THE SUPREME COURT AND HIGH COURTS AND NO ADVOCATE IS TOUCHING THE ISSUE FOR FEAR OF REGISTRY WHO WILL KILL THEIR CAREER AND PRESSURE FROM THE CONCERNED BAR COUNCILS.

It is proved beyond reasonable doubt that REGISTRY, SCAORA, BCI AND BAR COUNCILS ARE STRANGULATING THE JUSTICE DELIVERY SYSTEM for their own politically affiliated agencies as the matter has been brought to their knowledge since 2020 and after six years approximately no office has taken any action in this matter and my letters to Hon'ble CJI JUSTICE GAVAI and Hon'ble JUSTICE NAGARATHNA on 10 09 2025 vide SPEED POST NOS EO858420365IN AND EO858420374IN and duly delivered in their respective addresses actually did not reach them and the registry had suppressed the letters in their custody as if it would have reached the Hon'ble Judges the result would have been different.

Under the circumstances you are requested to take appropriate steps to regulate the unruly advocates, AORs and unholy nexus of the Government with the registry of Supreme Court as ONLY TRUST WORKS IN JUDICIARY AND ADVOCATES EARN THEIR LIVELIHOOD FROM THIS TRUST OF THE CLIENT ON JUDICIARY and they should be prohibited from killing judiciary for their political aspiration.

I am only waiting for the day to upload this matter in SOCIAL MEDIA or some YOUTUBER SITTING OUTSIDE INDIA to broadcast this as our legal luminaries are afraid to handle this crisis in judiciary and registry and as seven years have passed in such type of negligence I cannot wait furthermore and waste my time unnecessarily.

So many activists are taking up issues of minor importance but hesitant to pick up this issue because of the wrath of the Government and stoppage of donations.
