SUBJECT-APPOINTMENT OF DGP IN ODISHA

It is pertinent to mention that as per media report the present DGP ODISHA is retiring on 16 08 2026 and the selection process for appointment of new DGP in Odisha is initiated at your level.

You are requested to consider the candidates for this post after verifying their bio data along with their declaration related to any favor in any form by them and their family members from the Ministers of Odisha in between 1995 to 2014 on affidavit like Discretionary Quota Plots availed during their tenure while serving the Govt of Odisha as some of your candidates shortlisted are under scanner as they have violated the AIS RULE and SUPREME COURT GUIDELINES as they have snatched the share of the destitute which is incorrect both morally and lawfully.

The list of these cadre officers along with their handwritten request letters on their official letterhead to the Minister of Odisha for themselves and wife and children are available in my PIL filed in SUPREME COURT based on my RTI documents. (COPY ENCLOSED)

As you are going to select and appoint the highest position in the Police force of Odisha he should be both ethically and legally clean to serve the people of Odisha not the political parties either ruling or opposition.

If it is not considered at this level then it will have lgal repercussions as per verdict of SUPREME COURT IN SC 2024 INSA 894 CIVIL APPEAL NOS 3791 TO 3793 OF 2011 ORDER DATED 25 11 2024 and this matter may be discussed at JANTAR MANTAR as the rights of the deserving persons to avail the DQ PLOT are grabbed by the cadre officers of Odisha by misuse of official position and power as indicated in the CAG REPORT given below.

CAG AUDIT REPORT 2014 2015 ODISHA DQ

A 2014-2015 CAG report highlighted massive irregularities in Odisha's Discretionary Quota (DQ) for housing, leading to the cancellation of 1,791 plots/flats by the BDA, CDA, and OSHB. The probe revealed that politicians, bureaucrats, and journalists, rather than the "distressed" individuals for whom the quota was intended, were the primary beneficiaries between 1995 and 2014.

Key Findings of the Scandal:

- **Misuse of Power:** The [Odisha government](#) discovered that the 10% DQ was frequently abused for non-transparent, multiple allotments to influential individuals.
- **Scale of Irregularities:** The review covered 1,791 allotments made over 20 years, with a task force finding 302 cases of multiple allotments to the same person or family.
- **Targeted Allotments:** Instead of victims of natural disasters or those in extreme hardship, many recipients were well-connected, according to [a 2012 Governance Now report](#).
- **Action Taken:** Following the report, the state government cancelled all such allotments, ordered a Vigilance probe, and initiated criminal proceedings against recipients who submitted false affidavits.

The discretionary quota was abolished on December 7, 2011, following persistent criticism of its lack of transparency.
