With due respect I am enclosing all the relevant documents as produced in Hon'ble ORISSA HIGH COURT which were perused by the Hon'ble bench of Chief Justice and the order was passed on 06 12 2022 to approach Lokayukta Odisha for appropriate action.

I am requesting Hon'ble Lokayukta to initiate enquiry under Section 13 of the Prevention of Corruption Act (PC Act), 1988 deals with a criminal misconduct by a public servant.

Section 13(1)(d)(iii) states that a public servant is said to commit the offence of criminal misconduct if he, while holding office as a public servant, obtains for any person any valuable thing or pecuniary advantage without any public interest.

There is serious apprehension that there is huge financial loss to the Odisha state exchequer by both the Ministers and Cadre officers by abuse of official position and above all violation of Hon'ble Supreme Court guidelines (copy attached) and no public declaration was made by the Odisha State Govt to make public aware about the land available under Discretionary Quota of the Ministers which

is mandatory according to Hon'ble Supreme Court guidelines while dealing with any public property as revealed under RTI.

Under the circumstances I request you to take up the matter in the interest of justice as a compliance to ORISSA HIGH COURT ORDER DATED 06 12 2022 IN WPC NO 9095 OF 2014.

With due respect I am informing your good office that the said PIL was filed based on all the RTI documents received from different offices.

Common Cause who is petitioner no 1 may take appropriate steps as per their convenience and I have already informed them.
