MY RTI DATED 08 02 2023 REGARDING LIST OF JUDGES MADE RAJYA SABHA MEMBERS, WHO JOINED POLITICAL PARTIES, OFFERED GOVERNORSHIP AND ANY OTHER POSITIONS ALLOTTED UNDER PRESIDENTIAL QUOTA FROM 2010 TO 2022 IN BOTH SUPREME COURT AND ALL HIGH COURTS

AND ANOTHER RTI DATED 08 02 2023 REGARDING ATR ON MY COMPLAINT AGAINST AOR OF GOVT OF ODISHA KIRAN KUMAR PATRA IN SLP CIVIL 21329 OF 2020

Diary no 11114/RTI/22-23/SCI dated 28 02 2023 posted on 03 03 2023 and received by me on 07 03 2023 and Diary no 11115/RTI/22-23/SCI dated 18 03 2023 posted on 22 03 2023 and received by me on 27 03 2023

Sir

With due respect I request you to register a case against CPIO AND ADDL REGISTRAR SUPREME COURT HIMANI SARAD FOR VIOLATION OF RTI ACT under the following grounds

- 1. The concerned CPIO should have transferred my two RTI applications as mentioned above to the concerned authorities UNDER SECTION 6 (3) OF RTI ACT instead of disposing it off bluntly by saying neither the information is maintained nor available and hence nil information in his diary no 11114/RTI/22-23/SCI dated 28 02 2023 posted on 03 03 2023 and received by me on 07 03 2023.**
- 2. It is pertinent to mention that my RTI application was related to the registry of Supreme Court against AOR OF GOVT OF ODISHA KIRAN KUMAR PATRA and ASST REGISTRAR XI A IN SLP CIVIL 21329 OF 2020 where both of them colluded together by making impersonation and professional misconduct where they misguided the Hon'ble Judges including CJI to get a stay and the said AOR KIRAN KUMAR PATRA being AOR OF GOVT OF ODISHA fought a case against GOVT OF ODISHA IN SLP CIVIL 21329 OF 2020.**

It is obvious that a series of complaints in this matter through email and registered letters were sent by me to SECRETARY GENERAL SUPREME COURT OF INDIA and other necessary parties who are directly or indirectly are aware of this issue and they are the regulatory authorities to regulate the conduct of the AOR and Asst Registrar but now under RTI the same registry of Supreme Court is replying that the information is not available with them.

There cannot be more disgraceful answer from registry of Supreme Court under RTI Act being the highest judiciary.

I do not hesitate to say that registry of Supreme Court is blocking all the correspondence of mine made to Hon'ble CJI by all means and not allowing the matters which are so serious than Adani Scam and replies on behalf of Hon'ble CJI on the complaints made against the registry.

There cannot be more mockery of justice delivery system where the Hon'ble Judges including CJI have been taken on a ride by its own registry with the help of the AORs of GOVT OF ODISHA.

Under the circumstances it can be inferred from the behavior of registry of Supreme Court that what AOR OF GOVT OF ODISHA KIRAN KUMAR PATRA has done is legally correct and it is proved from the silence and inaction of all the top brass to whom the emails are sent in this matter from 2020 to 2023.

As per RTI reply vide Diary no 11115/RTI/22-23/SCI dated 18 03 2023 posted on 22 03 2023 and received by me on 27 03 2023 from CPIO AND ADDL REGISTRAR SUPREME COURT HIMANI SARAD; the CPIO has misinformed and misguided me by para 2, 3 and 4 of the reply as I had asked a copy of ATR against AOR OF GOVT OF ODISHA KIRAN KUMAR PATRA for his misconduct and impersonation where he misguided several Hon'ble Judges including CJI which is in the knowledge of Registry of Supreme Court.

INSTEAD OF PROVIDING ME THE COPY OF ATR WHICH BELONGS TO THE DOMAIN OF REGISTRY OF SUPREME COURT; THE CPIO IS TRYING TO MISGUIDE ME UNDER SEVERAL RULES AND REGULATIONS AND PORTRAYS AS IF I HAD ASKED CERTIFIED COPIES OF SLP CIVIL 21329 OF 2020 AND INSPECTION OF JUDICIAL RECORDS WHICH IS NOT A FACT.

THE CPIO HAS ALSO INFORMED IN PARA 2 OF THE LETTER THAT AS THE EMAIL ID OF THE INFORMATION SOUGHT WAS NOT PROVIDED BY ME THE RTI REPLIES CANNOT BE PROVIDED. THE CPIO SHOULD CLARIFY WHAT EMAIL ID IS REQUIRED AS THE REPLY IS VAGUE IN NATURE.

Therefore you are requested to register the case against the said CPIO and show cause why he has not followed RTI Act and told lies that they don't have information.
