It is pertinent to mention that JICA JAPAN should be well aware of the facts that where it's good money is used and it should monitor the funding and its agencies who are using the money or else all the efforts of JICA JAPAN will go down the sewerage and without its knowledge the money will be siphoned by the executing authorities and as it is coming under housing and urban development Odisha directly they can do anything with the good money of JICA JAPAN like they did it with the land of Odisha state through its HUD ministers and the case is registered in Lokayuta vide case no LY 198/2023 on my complaint.

OWSSB and L&T are equally partners in this corruption as implementer and contractor and JICA JAPAN is equally responsible in this being the financier and the ED New Delhi will decide the percentage of crime and corruption for going ahead with a project in OUR PRIVATE LAND WITHOUT PERMISSION OF GOVT OF ODISHA despite of my repeat objections to this and being fully aware of the fact you implemented the project in our private land.

It attracts abetment to crime and corruption and you took several years to send this letter to declare JICA JAPAN is a funding agency which is known to every child of gallis of Cuttack who are suffering from your great sewerage project since 2013 for over 10 years and nothing new you have informed me.

JICA JAPAN was well informed by me about ten years ago and the PMO was also informed about this and after ten years JICA JAPAN is trying to save its skin as they are anticipating a long legal battle in top court/LOKPAL/LOKAYUKTA for funding the project without application of brain giving rise to several litigations for their unlawful activities.

All my allegations stand as it is against JICA JAPAN, JICA INDIA and their staff including others as mentioned above and stop threatening us for not using JICA name out of context except funding which sounds ridiculous.

As per common sense the financier of any project is equally responsible if any crime/corruption is committed otherwise why NIA is arresting the persons who are involved in terror funding as factually they are not directly committed the crime.

JICA JAPAN can be charged with allegations of pumping money into state projects without application of brain and monitoring which gives rise to corruption in the respective states and in lieu of that there must be quid pro quo and both CAG and Principal AG should audit the funding and expenditure of JICA project.

In point two of your letter you have stated OWNERSHIP TRANSFER DOCUMENT OF CHEMICAL COMPOUND MAHAMADIA BAZAAR AND DETAILS GIVEN IN EMAIL DATED 08 02 2023 is beyond the purview of your office and it is to be mentioned that if it is beyond the purview of your office then how you have entered to a private property without verifying the facts, land documents and consulting with owner staying next door, making any written communication with the owner to take his consent etc; instead of that like hooligans you have installed your chambers with the help of sahi committees and encroachers of our land. So your point two is not justified and will be decided in the court in due course.

Regarding page no 2 of RTI reply the concerned clerk dated 27 10 2016 has admitted that JICA had constructed the chambers where everybody is using the road and stated that water pipes, telephone poles and electric poles are installed and so the clerk gave the judgement that the JICA work is legal and he made a map and submitted in page 3 of RTI reply.

AS A COUNTER TO THE PAGES 2 AND 3 OF RTI REPLY OF YOURS; IT IS TO BE CLARIFIED THAT BOTH THE CLERK CMC AND THE UNKNOWN SECRETARY CMC HAVE NEVER USED THE SENTENCE THAT THE PRIVATE LAND WHERE JICA HAD CONSTRUCTED THE CHAMBERS IS TRANSFERRED TO CMC CUTTACK AND SALE DEED WAS DONE IN THE NAME OF CMC CUTTACK FOR PUBLIC UTILITY.

SO IT IS UNDERSTOOD THAT CMC, JICA AND THEIR CONTRACTOR L & T HAVE INTRUDED INTO THE PRIVATE LAND WITHOUT THE CONSENT FORCEFULLY WITH THE HELP OF THE ENCROACHERS LIKE THE ADVOCATE SASHIBHUSAN DAS AND HIS WIFE SALILA JENA AGAINST WHOM EVICTION CASE IS PENDING IN ODISHA HIGH COURT AND CASE OF PROFESSIONAL MISCONDUCT FOR CHEATING HIS CLIENT AND FORCEFULLY GRABBING THE PROPERTY OF THE CLIENT BY CRIMINAL BREACH OF TRUST IN BAR COUNCIL OF INDIA NEW DELHI.
