**YOUR GAZETTE NOTIFICATION IS SILENT ON SUB METERS AND LANDLORD AND TENANT BUSINESS AND ALLOWING A SAFE PASSAGE TO TPCODL FOR MANIPULATING THE UNITS BY TPCODL STAFF.**

**YOU HAVE NOT CLARIFIED THAT HOW YOU ARE CALCULATING THE 20% OF THE TOTAL CONNECTED LOAD IS USED FOR “NON-DOMESTIC PURPOSE LIKE OFFICE AND CONSULTANCY CHAMBERS AND OTHER MISC” AND WHY TWO SEPARATE METERS ARE NOT USED FOR SEPARATE PURPOSES.**

**The CMO’S OFFICE IS REQUESTED TO INITIATE ENQUIRY OF POWER THEFT MADE BY THE LANDLORDS SPECIFICALLY IN WARD 12 OF CMC CUTTACK regarding in the matter of renting out their buildings to hundreds of tenants and collecting house rent which is revenue generation and commercial in nature but the meter is in DOMESTIC CATEGORY and only ONE METER IS IN THE NAME OF LANDLORD AND LANDLORD KEEPS ON INSTALLING SUB METERS AND COLLECT ELECTRIC BILL FROM THE TENANTS AT THE RATE OF WHAT THE LANDLORD DECIDES AND PARALLEL DISCOM COMPANY IS IN OPERATION AND THE PROFIT IS SHARED WITH THE TPCODL STAFF.**

**THE LANDLORDS OPERATE GROCERY SHOPS, PAN SHOPS, HOMEIO CLINICS, TAILORING SHOPS, MUTTON SHOPS, SELLING OF SECOND HAND MOTORCYCLES, COACHING CENTERS, WELDING SHOPS, AUTO REPAIR SHOPS INCLUDING SHOPS SELLING AUTO ACCESSORIES, ATMS, FILIGREE SHOPS AND ABOVE ALL PRESS FROM THEIR RESIDENCE AND PAY DOMESTIC TARIFF.**

**IT IS IN THE KNOWLEDGE OF TPCODL STAFF STARTING FROM METER READER, AM, DGM, GM AND CEO.**

**IT SHOWS HOW MUCH CORRUPTION HAS ENTERED INTO TPCODL IN CUTTACK AND WARD 12 MAYBE THE TIP OF THE ICEBERG.**

**IT IS IRONICAL TO SEE THAT THE SWEEPERS OF CMC WHO ARE WORKING WITH PRIVATE CONTRACTORS ARE VIDEOGRAPHED IN SMART PHONE BY THE SUPERVISOR DAILY TWICE IN THEIR UNIFORM, GARBAGE TROLLEY, JHADOO ETC TO ENSURE THEIR SALARY FOR THAT DAY TO PROVE THAT WE ARE HAVING THE UTMOST TRANSPARENT GOVERNANCE IN THE STATE AND IT IS A MOCKERY OF WHOLE GOVERNANCE WHERE THOUSANDS OF CRORES OF TAXPAYER'S MONEY IS SIPHONED BY THE CADRE OFFICERS WHO ARE IN CHARGE OF DEPARTMENT OF POWER IN OUR STATE ONLY MANIPULATING DOMESTIC AND COMMERCIAL TARIFF AS WELL AS SUB METERS.**

**Under the circumstances the Govt should act to eradicate the mass corruption done by the landlords in connivance with TPCODL IN WARD 12 OF CMC CUTTACK in the first round by following the example of the transparency maintained in the matter of SWEEPERS in CMC CUTTACK or else it will end in another case of disparity and inequality shown to the weaker section of the society.**

**Like Form A in Lokayukta, TPCODL should introduce a Form to be filled up on affidavit by the consumer mentioning approved load, use mentioning domestic or commercial, number of rooms, number of tenants, number of persons dependent on the meter, source of income, approx monthly income, details of electric and electronic appliances used on that meter, number of sub meters used and installed by whom and in whose name, operating printing press and welding shops which are high energy consuming machines from the residence, number of ACs with details as it is directly related to the income and is the main source of power theft which results in explosion of transformer and fire in cables which recently happened in ward 12 of CMC to begin with.**

**You are requested to clarify the irregularities mentioned above and what action you have taken because the irregularities are still continuing as it is till date.**
