**Subject-Fake Driving Institutes in Odisha particularly Cuttack**

**Respected Sir**

**Please refer to your letter no 1364819/MIN/RT&H/VIP/2019 dated 23 12 2019.**

**I had requested you in my letter dated 02 12 2019 to intervene in the matter of Fake Driving Institutes in Odisha particularly Cuttack which you had forwarded to Joint Secretary (Transport) for examination and appropriate action.**

**It is unfortunate to say that although approx three years have passed no action has been taken in this matter and no communication from your end till date. Even after my repeat reminders to the state govt including RTO Cuttack, DCP Cuttack, IIC Lalbag Cuttack, ACP Traffic Cuttack, DGP Police HQ Cuttack, CP Bhubaneswar and Secretary of the concerned Dept; not a single step has been taken although the video and photo of the fake driving institute called "Gajanan Driving Institute" was provided through email and speedpost (attached).**

**It is quite surprising to see your utmost effort and heavy fine in HELMET CHECKING, PUC, HSNP ETC on the excuse of safety whereas you are silent in manufacturing of fake drivers and allowing them to drive the vehicles throughout India in connivance with RTO and police who facilitate the whole procedure which is illegal legally.**

**Your ministry should take note of urgency of the matter which is spreading like epidemic and ministry should constitute centrally administered task force to control the menace of fake driving institutes in Odisha and all over India as if a person wears two ISI helmets also he will be crushed to death by the fake drivers licensed by the state RTOs to kill.**

**Please treat this as a compliance to PIL guidelines for intervention of Hon'ble Court as I have already informed all the concerned authorities and because of their quid pro quo from the process; they have remained defunct and allowed the culprits to rule the roads at the cost of public life and property.**

**The root cause of the menace of the road accidents is fake driving institutes which run with the support of state govt officials and the centre should take charge like HELMET CHECKING, PUC, HSNP ETC or else helmet checking is just an eyewash.**

**Waiting for your reply and opinion or else I shall be forced to move the Court for appropriate direction.**
