It is pertinent to mention that huge number of mutton and chicken shops are operational in the open ground in front of Barabati Stadium which is violation of Commissionerate Police Act.

As per the UPD Act obtained under RTI the above activities are not permissible.

It is also needs to be informed that in Cuttack city mutton and chicken shops are mushrooming in all the residential areas even next to grocery shops, medicine shops, vegetable shops, tea and paan shops, shoe and chappal shops, electrical repairing shops, OMFED Booths and it speaks for itself for the willful and deliberate inaction by the concerned local PS and for the inaction there is every chance of quid pro quo.

It seems that all the mutton and chicken shops are the sister concerns and side business of the above shops mentioned as they allow them to operate and every alternative shop has a mutton and chicken shop with mobile numbers to contact for order.

So under the circumstances it is observed that the administration has failed miserably and non-functional willfully.

You are always awaiting a judicial intervention to be on correct side of the law and need court monitored supervision through court commissioners consisting of advocates appointed by the court; so reforms are necessary to keep the police under direct supervision of the Hon'ble High Courts and not under the jurisprudence of political masters.

Perhaps we are heading towards the reforms as it has already started in Cuttack in the matter CMC and why not Commissionerate Police of twin cities.

I may move the Hon'ble High Court in the above matter along with other areas which badly affected with overflow of mutton and chicken shops in every galli and bylanes of Cuttack like Lord's Hotel, Rausapatna, Seminary Chhak, Odia bazaar, Kazi Bazaar, Mahamadia Bazaar, Shiekh Bazaar, Ganesh ghat petrol pump, CDA sector 6,7,9,10 which give a VIVID PICTURE OF BRUTALITY AND VIOLENCE AND NON-EXISTENCE OF ANY LAW AND ORDER AND POLICE EXISTENCE IN THOSE AREAS.

You are advised to correct the illegality at the earliest.
