with due respect I want to bring
to your kind notice certain facts received
under RTI from Hon. Odisha High Court.

2. I had made a letter petition dated 21/1/21 to the Honble. Odisha High Court and Hon. Supreme Court to take suo motu cognizance in the matter above mentioned where illegal sand filling of River Mahanadi at Cuttack is done without taking any environmental clearance.
3. The unfortunate part is that the versions of Odisha Govt were different in the same matter in Hon. Odisha High Court and Hon. Odisha Human Rights Commission. (All the annexures were provided with the main petition dated 21/1/21)
4. Under RTI it has been replied that my petition dated 21/1/21 was placed

before Hon. Chief Justice and after due consideration the petition has been filed under "NO ACTION" category. In Odisha High Court, CPTI copy dated 22/4/21, letter No. 5302_ is enclosed)

5. Prima Facie the documents filed in the Hon. OHC and Hon. OTRC were certified by Govt. officials and the Govt. Advocates must have gone through the documents before placing the records in the legal forum.

6. It is an open and shut case of contempt of court by the Odisha Govt officials and the Govt counsels appearing before the Hon. Courts and commissions.

7. The Hon. Court should have called for the records from Hon. OTRC before putting it into "NO ACTION" category and called for the Satellite Pictures of Sand filling of River Mahamadi and should have issued notice to the Odisha Govt for clarification on 2 different versions in 2 Hon. Judicial Forums.

8. Such type of "NO ACTION" category gives moral boost to the Govt officials along with their Govt Advocates to misguide the Hon. Courts and such type of offence are at high,

9. Such type of "NO ACTION" category is giving a wrong message for the people believing in Indian Judiciary and such type of Ex-Party categorisation of "NO ACTION" is not good for the society.

10. It also gives a feeling that misguiding Hon. Courts on affidavit-duty hearing of PIL matters by Govt officials and Govt Advocates is "acceptable" and it is different for ordinary common man.

11. It is also pertinent to mention that there are Persons placed in Odisha Human

Rights Commissions who have Political
affiliation and Violated Hon. Supreme
Court guideline in allotment of
Discretionary Quota Land / Plots under
Ministers of State Govt of Odisha,
(Available in the website under RTI)

12. Fortunately NGT had intervened in
the Sand filling of River Mahanadi at Cuttack
and process it at hold and my petition with
NGT is still under Process.

13. With due respect I request you to intervene
in the matter of Letter Petition dated 21/1/21 and
the RTI reply dated 22/4/21 of Hon. OHC in "NO ACTION"
category in the interest of Justice and Pride of
Indian Judiciary.
