SUBJECT-OLD AGE HOMES FOR SECURITY AND WELFARE OF THE SENIOR CITIZENS OF MIG SEGMENT IN INDIA IN TWILIGHT YEARS SUPPORTED BY CENTRAL GOVERNMENT AND HIGHER JUDICIARY

Respected Sir/Madam

I have initiated the matter in Orissa through Orissa Human Rights Commission (OHRC) and in India through NHRC with very limited success because their primary focus is different.

It is unfortunate to say that the human rights of senior citizens of Middle Income Group (MIG) are truly violated as the state till now has no accountability towards the MIG segment as they are not dependable vote banks in the absence of digital voting with all precautions.

The MIG segment spent their whole life towards their family and for the state as tax payers but left alone when they really need physical/mental/psychological support. They definitely do not want any financial support from anybody as they are on the verge of giving everything when they depart but they really do not get what they need in their twilight years.

As the life expectancy has increased upto approximately 90 +; the retirement life from 60 becomes a burden and it is spent in regret thinking what they have done and what they should not have done; which can be best spent in old age home with required facilities and peace of mind with a homogenous segment of people primarily in terms of age and requirements.

They have finance but it is not everything although it is everything but with a trustworthy, honest and dependable companion from the STATE.

Being a developing country with population explosion where the BPL and LIG segment are the king makers; the emphasis is always made by governments to help them with different schemes and rightly so but such schemes do not apply to the MIG segment because their needs and wants are different.

The children of MIG segment prefer to work outside preferably abroad and do not want to get stuck with for example MSME type family business hence the old parents are always left alone.

Unfortunately the joint family system in MIG segment is gradually disintegrating due to respective compulsions and so there is always threat to life and property of the senior citizens of MIG segment and the survey report will substantiate the increase in crime against senior citizens of MIG segment.

In regular interval there are newspaper reports about crime against senior citizens of MIG segment. Even retired defense, government and corporate officials and ex businessmen living in posh localities are not safe and the police personnel are too busy with law and order.

Senior citizens of MIG segment are easy prey to the criminals because of no immediate back up plan and if they have some limited security then ironically they have more threat.

The necessity is a 24x7 CCTV and DIGITAL SURVEILLANCE of the said segment for which they should pay fully but the crux of the story is to whom they will trust and who is accountable.

In my humble opinion it may be handled by Hon'ble Supreme Court of India by instituting social security societies under the surveillance of state High Courts as they have done in providing legal aid for MIG segment in many of the High Courts through legal aid societies which are financially self sustaining and not subsidized by state in any manner. It can be supervised at district level by the Hon'ble District Judges under the guidance of sitting Judges of High Court as they handle the administrative part of lower judiciary districtwise with the help of security personnel provided by CISF or any other similar security personnel recruited by the central government. Suitable land should be provided by all state governments at the behest of central government and higher judiciary. Since state governments are already into similar projects of old age homes for BPL segment and LIG their involvement should be limited in terms of involvement of revenue and police departments. This is because state governments' old age home projects are almost totally funded by state government schemes with very limited budget and facilities whereas the proposed project of old age homes for MIG segment would entail initial investment in lakhs of crores of rupees but it will be funded initially by central government, top corporates as PPP and persons from MIG segment through initial subscription and it should be self sustaining where SENIOR CITIZENS OF MIG SEGMENT IN INDIA IN TWILIGHT YEARS will PAY AND STAY WITHOUT ANY GRANT OR SUBSIDY WHATSOEVER. The new role of CENTRAL GOVERNMENT and HIGHER JUDICIARY in this project would be to provide leadership and peace of mind to senior citizens of MIG segment and provide reliefs guaranteed under Article 21 of the constitution.

The things are in fluid state and a detailed case study by reputed institutes and foundations is required.

I shall be obliged if you take up the matter in the interest of providing safety and a peaceful life to the senior citizens of MIG segment in India which they deserve and frankly speaking they have no choice except counting the day in anxiety and disgrace. IT MAY BE ONE OF THE MAIN REASONS WHY NRIS OF MIG SEGMENT PREFER TO STAY IN OLD AGE HOMES IN DEVELOPED COUNTRIES RATHER THAN RETURNING TO THEIR MOTHERLAND IN THEIR TWILIGHT YEARS.

OLD AGE HOMES IN DEVELOPED COUNTRIES IS A NORM RATHER THAN AN EXCEPTION BECAUSE THEIR POPULATION ALMOST ENTIRELY BELONGS TO MIG SEGMENT.

OLD AGE HOMES IN DEVELOPING COUNTRY LIKE INDIA MAY BE TAKEN UP AS A DESIRABLE EXCEPTION AMONG DEVELOPING COUNTRIES.

A helping hand is a must and time has come for the top corporate sector to take initiative as PPP as a corporate social responsibility not so much in terms of land or funds but definitely use of their corporate skills in managing difficult situations.

Case no.2925/2019 put up for hearing on 20/01/2020 and hearing on 19/01/2021

Respected Sir

It is pertinent to mention that I have received a reminder regarding the above mentioned case dated 29/01/2021 on 02/03/2021 by speedpost.

It is unfortunate to say that I have not been informed about the four hearings dated 20/01/2020, 17/03/2020, 12/05/2020 and 19/01/2021 as mentioned in the order dated 19/01/2021 and I was in total dark about the proceedings.

It is unfortunate to say that as mentioned in the order dated 19/01/2021 regarding "no response is forthcoming from the complainant as called for vide order dated 17/03/2020" is not received by me by any form of communication.

It is pertinent to mention that I had sent an email dated 26/12/2020 seeking the status of the abovementioned case and later on sent an extract of the email on 08/01/2021 by speedpost no. EO998972395IN for your kind perusal and surprisingly the records related to the email and speedpost were not put up during the hearing on 19/01/2021 as there is no mention is made in the ordersheet.

It is pertinent to mention that I have also not been served a copy of reply to my complaint from Commissioner cum secretary to Govt for Social Security and Empowerment to give counter-reply to that.

It is unfortunate to say that the commission without informing me about the version of the side of Govt in the abovementioned case passing negative remarks about me that I am not responding and issuing reminder which is a sheer case of miscarriage of justice as I do not know what to respond.

I request to provide me the details of all the three hearings as mentioned above and the counter reply of Commissioner cum secretary to Govt for Social Security and Empowerment who was directed by the Hon'ble OHRC to provide prompt report with suggestions by 20/01/2020 in the order dated 29/11/2019.

I also request you to clarify why my email and speedpost as mentioned above are not considered during hearing on 19/01/2021 because those communications have the answers to the order dated 19/01/2021.

It is pertinent to mention that miscarriage of justice has been done in my complaint case related to illegal sand filling of River Mahanadi in Cuttack where I had not been served a copy from the side of Government in Case no. 496 of 2020 with an order dated 11/06/2020, signed by Asst Registrar on 04/08/2020, dispatched on 01/01/2021 by ordinary post and received by me on 04/01/2021.

I was not given a single chance to respond as it is done in my other cases by sending reminders and the case was disposed of without considering my side of version and it is pertinent to mention that I had sent a request petition to repeal the order because injustice has been done and proper law

process is not followed in Case no. 496 of 2020 related to illegal sand filling of River Mahanadi in Cuttack and the case was disposed of in a hurry.

It is pertinent to mention that Govt officials are FILING FALSE AFFIDAVITS in Hon'ble High Court Odisha regarding illegal sand filling of River Mahanadi in Cuttack and providing another version about illegal sand filling of River Mahanadi in Cuttack in OHRC based on which the Hon'ble OHRC is disposing of the case one-sidedly without giving me a chance to counter the version of the Govt.

I have already brought the matter about FILING OF FALSE AFFIDAVITS by Govt officials to the kind notice of Hon'ble Chief Justice of India and Hon'ble Chief Justice of Odisha High Court by speedpost.

I request you to provide me the documents as asked above in the interest of justice.

With due respect I want to mention that the above mentioned case was put up for hearing on 20/01/2020 before the division bench.

The Hon'ble Chairperson had gone through the contents of the grievance petition dated 21/11/2019 to take suo motu cognizance in the matter of human rights violation of aged senior citizens belonging to Middle Income Group (MIG) of Odisha state and passed the order dated 29/11/2019.

The above order directed the Commissioner cum secretary to government, Social Security and Empowerment of persons with Disabilities Odisha to give PROMPT REPORT WITH SUGGESTIONS to reach the commission by 20/01/2020.

It is very unfortunate to say that although one year has passed no development has taken place in the above case and no communication has been made to me about the status of the case till date.

I request your good office to hear the above matter on urgent basis as ages have passed and no concrete steps have been taken by any government for the security and welfare of the senior citizens of MIG segment of Odisha state.

The government may be issued direction for immediate action to be taken in the above matter and if not possible to conduct the project alone it can go ahead in PPP mode as it is trying in other areas like sewerage, roadways, power distribution etc because they have expertise and profit incentive as corporate sector.

My grievance petition related to the above matter is a self sustaining project as the MIG segment are the major tax payers to the state exchequer out of which all the governments spend that money on vote bank appeasement politics.

It is pertinent to mention that the same revenue generating segment who subscribed throughout their life to the society and their family members in the form of cash, kind, time, energy, emotions, wisdom etc are left at the mercy of nature unattended in their twilight years.

Nobody is ready to take responsibility and want to be accountable for them although people are very much interested for their votes to come to power and their wealth is very much required by their family members DURING THE TENURE OF THEIR LIFETIME NOT AFTER THEIR DEMISE.
