**Respected Sir**

**With due respect I want to draw your kind attention towards the above mentioned matter.**

**It is pertinent to mention that the cadre officers are violating the AIS rule and separation of power is also at stake in Odisha after Discretionary Quota scam. Please refer to WP(C) 1096 of 2013 filed in Hon'ble Supreme Court and WP(C) 9095 of 2014 and CMAPL 298 of 2015 filed in Hon'ble Orissa High Court in this matter.**

**The cadre officers are supposed to show their loyalty to the chair and not to any political party but ironically it is seen that cadre officers are very much interested to please the minister in anticipation of getting some post after retirement or taking VRS as there is NO STRICT MANDATORY GUIDELINE FOR COOLING PERIOD TO JOIN POLITICS.**

**By taking advantage of such SERIOUS LEGAL LOOPHOLE in the system the political masters always identify the blue eyed cadre officers who are easy prey for quid pro quo and it is already proven in state of Odisha revealed under RTI ( WP(C) 1096 of 2013 filed in Hon'ble Supreme Court from Page 44 to 149 copy attached).**

**It is necessary to say that some of the cadre officers who hold the rank of Chief Secretary, State Election Commissioner, Special Relief Commissioner, Commissioner of Police, DGP, number of Collectors and SPs of the state who are the beneficiary of Discretionary Quota in gross violation of Hon'ble Supreme Court guidelines. It can be proved from the request letters in official letterhead misusing official position to the minister to get a piece of plot (WP(C) 1096 of 2013 filed in Hon'ble Supreme Court from Page 44 to 149).**

**Under the circumstances it can be easily inferred that during last 30 years the gross misconduct of abusing the official position to appease their political masters is still continuing.**

**Some cadre officers are still showing some special gestures beyond their line of duty to the high command of ruling party like taking photograph personally/individually on public road to show his closeness and having special position in the power circle and is trying to give a message to the people of Odisha at large that he is the next to the high command.**

**The objection comes as this facility is not given to anybody else like other cadre officers ie DGP, SP, DCP, Collector to take photograph at personal level in personal camera/mobile phone and this is a sure case of favouritism and abuse of official position of the said cadre officer. The irony is that the authority is happily allowing the cadre officer to take his personal photograph surrounded by his security men which is captured by media (Odiya Newspaper PRAMEYA Cuttack Edition dated 28 08 2021 page 13).**

**Such photo session could have been easily done inside the lok seva bhawan without public notice and it seems it is an intentional activity to send certain message to people of Odisha. The cadre officer should clarify that why it should not be treated as misconduct and it is in contradiction to AIS rule.**

**The public has full freedom to take photograph and interact with the authority as they vote them to power not the selective cadre officer who are bound by AIS rule and has to follow it in letter and spirit and should not be attached to some political persons personally as tomorrow the power may shift.**

**The cadre officer should show his loyalty to the people of Odisha not to the political master.**

**In near past A TOP CADRE OFFICER from CAG Odisha who was investigating the irregularities of DQ scam during 2012-2013-2014 in Odisha suddenly resigned from the post and joined the ruling party and now he is Rajya Sabha MP.**

**It shows a clear case of quid pro quo and there are many examples which need a judicial intervention.**

**It is high time that the Hon'ble Supreme Court takes suo motu cognizance in this matter and allow to re-open the case to protect the common man from the clutches of corruption and establish the rule of law and preserve the separation of powers.**
