REPRESENTATIONS FILED IN HON'BLE SUPREME COURT OF INDIA TO TAKE SUO MOTU COGNIZANCE in various matters.

 Filed a petition with a request to take suo motu cognizance regarding appointment of Hon'ble Retired Judges to avoid conflict of interest in all the commissions both in states and centre as it happens by the appointment of 'favored' cadre officers after their retirement or taking VRS.

The ground for filing the petition is it hits the impartiality and independence of the commission as the cadre officers have served both the ruling party and opposition during their tenure.

The Hon'ble Supreme Court has registered this case as Diary no 28717/SCI/PIL(E)2020 vide SMS dated 16/07/2020 and as Diary no 29473/SCI/PIL(E)2020 vide SMS dated 20/07/2020.

Filed a letter petition to Hon'ble Chief Justice of India on 03/10/2019 to intervene in the
matter of conflict of interest existing in Disciplinary Committee of all State Bar Councils and
Bar Council of India conducting actions against their fellow advocates who voted the council
members to power.

There is every apprehension of miscarriage of justice to the client because of the faulty mechanism. The letter was addressed to Ministry of Law and Justice New Delhi and Ministry has referred the matter to the Secretary Bar Council of India vide letter no E.O.N-345445/R&I/2019 dated 27/01/2020.

In the same petition it was also requested to activate Middle Income Group Legal Aid Society in the interest of justice which was inaugurated by Hon'ble Chief Justice Shri Deepak Misra in Odisha High Court.

The Hon'ble Chief Justice was requested to correct the mistake of law prevailing in all State Bar Councils and Bar Council of India.

The Hon'ble Supreme Court has registered this case as Diary no 28717/SCI/PIL(E)2020 vide SMS dated 16/07/2020 and as Diary no 29473/SCI/PIL(E)2020 vide SMS dated 20/07/2020.

3. Filed letter petitions to Hon'ble Chief Justice of India on 11/03/2020 and 14/05/2020 to take suo motu cognizance in the matter of illegal sand filling of river Mahanadi for commercial project by Odisha Government specifically and other rivers by any other state (if) which violates Article 21.

The Hon'ble Supreme Court has registered this case as Diary no 19533/SCI/PIL(E)2020 vide SMS dated 01/06/2020.

It is pertinent to mention that the Odisha Government has not obtained by NOC for filling sand approximately over 400 acres for commercial project in the heart of Cuttack city as revealed under RTI.
