PIL WP(C)13004/2022 REGARDING FINANCIAL IRREGULARITIES IN BPL/RATION CARD SCHEMES

Respected Sir

Pls refer to the above mentioned letter where you have mentioned that the information solicited by me relates to the Finance Dept and they should supply the information directly to me under intimation to your office.

The information solicited in RTI are related to Details of Definition of Middle Income Group (MIG), Eligibility criteria of MIG segment in Odisha to avail Govt Schemes, Exclusive Schemes for MIG with expenditure details as audited by you in between 2015 to 2021.

Details year wise about the expenditure of Odisha Govt on BPL Schemes with classification of expenditure separately for each scheme in between 2015 to 2021 as audited by you.

Details about eligibility criteria of BPL/RATION CARD holders which includes Income Certificate which is necessary to avail the scheme but there is no guideline for issue of Income Certificate and it is revealed under RTI that from 1997 there was no survey in this field then how you have audited the expenditure without any document and whether you have issued any objection to the Odisha Govt or not.

It is pertinent to mention that all these matters concern strictly to your domain then how and why you have transferred this RTI applications in a single day of receiving it to the Finance Dept Govt of Odisha needs to be explained by you.

I have solicited your opinion and copy of your audit report not of Finance Dept.

You are a watchdog of financial irregularities committed by the state when it spends the taxpayers money in tons of crores in the name of Poverty Eradication and it is your duty to scrutinize line by line all the expenditures incurred under different heads by the cadre officers of the State of Odisha most of whom including Chief Secretary to Home Secretary to SRC to DGP are Discretionary Quota holders

which was long back in 2012-2013 was enquired by the then AG Odisha who turned to be a loyal political worker after retirement/VRS and sent to Rajya Sabha for his loyalty to the political party for suppressing the crucial facts of corruption contradicting Supreme Court guidelines.

Surprisingly your audit report as solicited is now asked from Mission Shakti, Soil Conservation Jharsuguda, Soil Conservation Sundargarh, Forest Environment and Climate Change Odisha and hundreds of other Depts of Odisha by Finance Dept of Odisha to provide the same and after five months of time with the Xerox copy of my RTI application, PAN card and copy of your letter are sent to me with a remark "It may be treated as nil".

It is quite unfortunate that the ordinary depts. who are afraid of you as normally people are afraid of auditors; in panic they are forwarding to other hundreds of branches under section 6(3) of RTI Act to save themselves from the financial irregularities actually committed specifically from 2002 to 2022 by siphoning the public fund into party politics.

It can be inferred by keeping hundreds of letters received by me from different depts. including Finance Dept Odisha Lok Sewa Bhawan in view that you have not performed your duty as AG of Odisha state by not doing true and fair audit of the Govt of Odisha.

When finance dept writes "It may be treated as nil" then why you thought it proper to transfer my RTI to them.

It is commonsense that why should they give your audit report and your viewpoint on certain issues where you are doing the auditing of them.

A PIL WP(C)13004/2022 is filed in Orissa High Court in the above matter and all the correspondence made to you and through you by various depts. will be produced in the court as rejoinder and you will be made a party to this irregularity as it is done in your knowledge and because of your negligence of duty crores of public money have been drained out which could have used in the interest of people of Odisha.

You are requested to provide the correct information as solicited without any dilution.
