Ref-Letter no 23011/1/2022 from DOPT North Block dated 31 03 2022 addressed to Chief Secretary Odisha

Sir

Pls refer to the above mentioned letter addressed to you where an instruction was there to redress the above mentioned grievance within 45 days and if there was delay an interim reply with reason of delay should be sent to me.

Although 45 days have passed not a single reply has been given to me but OPEN AIR SLAUGHTER IN PUBLIC VIEW IN CUTTACK has drastically increased as a counter to the instruction from Under Secretary DOPT New Delhi. It shows that you give a damn to the DOPT who happens to be your regulatory authority.

It is very shameful to see the lawlessness prevailing in Cuttack and abrupt violation of both Commissionerate Police Act and Cuttack Municipal Corporation Act where hundreds of goats are tied by the butcher for slaughter in Biju Patnaik Chhak next to Anand Bhawan the ancestral building of CM

odisha and the place of butchery is going on fearlessly in the heart of residential buildings; in front of TPCODL office and a 100 m approx from the residence of Collector Cuttack.

The butchery goes on day and night on public road in public view and it comes under Cantonment PS Cuttack and PCR vans are seen standing right in front of the butcher's shop and it seems they have full co-operation and consent for the illegal act of slaughtering the animals in public place in public view and there must be some gain either in cash or in meat by the police.

It cannot be imagined that such broad day violation of law in the presence of police can be done next to a premium PS like Cantonment without their full support.

Inspite of my repeat reminders regarding the above matter you have not moved an inch rather you have allowed the lawlessness in Cuttack city where DCP Cuttack, Commissioner Cuttack Municipal Corporation and Collector Cuttack are equally responsible and perhaps they have been instructed NOT TO ACT by you for appeasing your political masters.

It is pertinent to mention that as you have been allotted plot under Discretionary Quota of the Housing and Urban Development Minister Odisha on your request letter in official letter head in the capacity of the then Collector Cuttack; you have already violated AIS rule and guideline of Supreme Court and OBVIOUSLY YOU ARE NOT ELIGIBLE TO GET A PIECE OF LAND UNDER DISCRETIONARY QUOTA AS IT IS ONLY MEANT FOR DESTITUTES, WAR WIDOWS ETC AND YOU ARE NOT FALLING UNDER ANY OF THE CATEGORY MEANT FOR DISCRETIONARY QUOTA.

As you have already violated your basic bible ie AIS rule for a piece of land you have no fear of law because of political patronage.

Time has come for re-shuffling the UPSC who selects IAS officers like you and it has to be made free from the clutches of political masters of respective states where the consent of political master is required to take any action against the cadre officer. Your office does not provide information under RTI and you do not have the list of Chief Secretaries from 1985 to 2022 as you did not provide the same under RTI.

Under the circumstances you have been proved dysfunctional and the administration is a total failure in Cuttack including DCP Cuttack, Commissioner Cuttack Municipal Corporation and Collector Cuttack as it is proven beyond reasonable doubt.

You are suggested to take VRS as you have violated both AIS rule and guideline of Supreme Court and have no moral right to be in the position of the Chief Secretary of Odisha.

You are also suggested to obey the instruction of DOPT atleast to save their face value or else it is a sure shot case of disobedience which is not good for a democratically run Govt as you are becoming autocratic and also inspiring your juniors to follow your path and gradually Odisha is heading towards lawlessness because your case inspires them not to obey law and our criminal justice system is not that efficient to punish such type of cadre officers.

The root of such illegality is deep rooted and wide spread which only can be uprooted by the Court and you take this representation as compliance to PIL guidelines.
