GATE AND NEAR ANAND BHAWAN BIJU PATNAIK CHHAK CUTTACK ODISHA**

**Sir**

**Please refer to my earlier emails and speedposts in the above mentioned matter for over last 5 years  
in regular intervals.**

**It is very unfortunate and disgraceful to say that not a single authority has taken any step in the  
matter and the scenario is becoming from worse to worst everyday where every gali of Cuttack is  
becoming hub of open air slaughter of animals and birds on govt encroached land.**

**It is pertinent to mention that the mutton shops are operational in front of the residence of sitting  
judges in Biju Patnaik chhak and next to the residence of number of retd judges of Orissa High Court  
and prominent advocates in kanika chhak/shelter chhak Cuttack and there cannot be more  
unfortunate failure of governance than this.**

**Both CMC and UPD Act are willfully violated in Cuttack only because of political patronage.**

**It is pertinent to mention that the CCTVs are installed in Biju Patnaik chhak which will give you the evidence of my complaint.**

**Under RTI CMC replied that there is no mutton shop in Biju Patnaik chhak near Anand Bhawan which is the ancestral property of the current CM. If this is the condition of governance near ancestral property of the current CM where everyday hundreds of animals and birds are slaughtered openly and the carcasses and the waste materials are dumped in the mini pond in front of Anand Bhawan and by the side of indoor stadium Cuttack then it can be easily imagined the condition of ordinary people of Cuttack.**

**We are everyday forced to see the slaughter in public place and we really do not have a platform to complain as the relevant law enforcing authorities have become political servants instead of public servants.**

**Under the circumstances I have no recourse except going to the Court to intervene in the matter with a prayer to provide the satellite picture of the concerned areas as I have serious doubt that the CCTVs are installed in such a manner that it does not capture the slaughter of animals and birds which are illegal.**
