Please refer to the above mentioned content and it is very unfortunate that no action has been taken in this matter in last 15 days and it proves that you have decided not to comply the RTI ACT as well as not in a mood to rectify the defects mentioned in my email dated 17 03 2022 to you.

It also shows that from PDS dealer in wards to the top brass do not want any sort of transparency in the PDS system where tons of tax payers' money is distributed ONLY FOR VOTE BANK POLITICS in the name of POVERTY IRRADICATION PROGRAMME without following proper SOP as well as the
