Sir

Please refer to your above mentioned letter demanding Rs 620 including postal charge for about 285 pages of list of ration card holders of ward 11 and 12 of CMC.

It is pertinent to mention that in my RTI application dated 17 02 2022 I had sought information about list of ration card holders along with father's name, spouse name, address name, number of RCC rooms, electricity load in KW, name of the person who has identified them along with copy of their application form for Ration card from 2014 to 2019 and 2019 to 2021.

You have not clarified about the content of your information you are going to provide me for Rs 620/- and it appears from your letter that you are going to provide me only the list of ration card holders of ward 11 and 12 of CMC.

I have already filed complaint to you by my letter dated 15 03 2022 by speed post and received by you on 17 03 2022 regarding non-updating of PDS dealers in your website about ration card holders of ward 11 and 12 of CMC.

It is mandatory to upload the names of ration card holders because of "ONE NATION ONE RATION" and it is claimed that everything has been digitalized.

Under the circumstances it is not advisable to spend huge amount of money for the list of the ration card holders which should have been made available free of cost if it was uploaded in your website.

Surprisingly after repeat reminders also you are not uploading the list of PDS dealers in your website about ration card holders of ward 11 and 12 of CMC.

You are suggested to clarify which information as mentioned in my RTI application dated 17 02 2022 you are going to provide.

After you give clarification categorically then only I will deposit the required Rs 620/- with you as one-tenth of the information is not worth it for Rs 620/- and for your default of up gradation of the system I should not pay for it.
