Nothing can be more unfortunate and disgraceful than this that such type of politics is played in the REGISTRY OF SUPREME COURT OF INDIA over last two years and not a single action has been taken against neither the GOVT OF ODISHA nor the said AOR KIRAN KUMAR PATRA who plays dual role for a private petitioner being the AOR OF GOVT OF ODISHA in SUPREME COURT OF INDIA against GOVT OF ODISHA.

Nothing can be more ridiculous than this that being fully aware the REGISTRY OF SUPREME COURT OF INDIA is allowing such type of criminality, misconduct as well as taking the Hon'ble bench of 3 Judges of SUPREME COURT OF INDIA for a ride by misrepresenting the case, falsifying my identity and

suppression of facts by all like AOR KIRAN KUMAR PATRA, GOVT OF ODISHA and REGISTRY OF SUPREME COURT OF INDIA.

Being fully aware of all the illegalities repeatedly brought to notice of you as well as SUPREME COURT ADVOCATES ON RECORD ASSOCIATION SUPREME COURT OF INDIA, TILAK MARG, MANDI HOUSE, NEW DELHI, DELHI 110001 scaora1@gmail.com admin@scaoraindia.com, CHAIRMAN BAR COUNCIL OF INDIA courtatters.bci@gmail.com and SUPREME COURT BAR ASSOCIATION scbaec@gmail.com; nobody has taken any action and from this it has inferred that this case may not be the first one and everybody is aware of such misconduct by the AORs is going on without the knowledge of the Hon'ble Judges.

The irony of Indian judiciary is that a common man needs an AOR to fight against another AOR for his professional misconduct both in the court as well as Bar Council of the state and Bar Council of India which can be compared to any other private association/club where the council members are elected by votes of the advocates and they don't want to displease each other for vote bank politics and there is serious conflict of interest in this process.

The irony of Indian judiciary is that a common man cannot approach an Hon'ble Judge directly and if a letter petition is sent the concerned registry suppresses the letter and it never reaches the judge. There is no direct connectivity through email with the Hon'ble Judges and all the emails are going through the registry and the power lies with them to delete it without bringing it to the knowledge of judges.

Under the circumstances it appears that some AORs and some Asst Registrars of SUPREME COURT OF INDIA have become more powerful than the Indian judiciary by the virtue of the protection from their advocate fraternity who protect them for their criminal professional misconduct.

If my grievance regarding the above issue is not sorted out and the concerned AOR and the Asst Registrar of SUPREME COURT OF INDIA are not punished as per law by bringing the SLP to the knowledge of the Hon'ble bench of 3 Judges of SUPREME COURT OF INDIA then I have to go to media including International Court of Justice.

I hope the Hon'ble Judges may come to know about the dirty game going on that to in SUPREME COURT OF INDIA from the media and I think the REGISTRY and SCAORA cannot block the issue in the media level.

You have already tested my patience for last two years by remaining silent and you have forced me to go to media as no other way is left and let the people of India know that what type of dirty game is going on in the corridor of REGISTRY OF SUPREME COURT OF INDIA.
