Respected Sir

It has come to my notice from the website of both Govt of Odisha Law Dept and Supreme Court Case status of SLP CIVIL DIARY NO 21329 OF 2020 that above mentioned both the AORs conduct cases for Govt of Odisha in Supreme Court.

It is pertinent to mention that the Govt advocate of Odisha agreed to obey the direction of Hon'ble Orissa High Court during the hearing in the case WP (C)PIL 19827 of 2017 which is challenged in Supreme Court by SLP CIVIL DIARY NO 21329 OF 2020 by AOR KIRAN KUMAR PATRA who is Advocate on Record for petitioner who is also Advocates on Record who conducts cases on behalf of the Government of Odisha before the Supreme Court of India. It can be inferred that Govt of Odisha is fighting the case in three fronts ie

one in Orissa High Court through GOVT ADVOCATE OF ODISHA IN FAVOUR OF THE ORDER ON BEHALF OF OPP PARTIES 1 TO 7

second in Supreme Court through AOR SHOVAN MISHRA FOR R-2 TO R-7 IN FAVOUR OF THE ORDER

third in Supreme Court through AOR KIRAN KUMAR PATRA FOR PETITIONER CHALLENGING THE ORDER

If the AOR KIRAN KUMAR PATRA FOR PETITIONER is the same person who conducts cases on behalf of the Government of Odisha before the Supreme Court of India and for the petitioner in SLP CIVIL DIARY NO 21329 OF 2020 then it is serious professional misconduct which is criminal in nature. As per Advocates Act the advocate cannot have the brief from the opposite side.

In this case the Govt of Odisha is equally liable in criminality where it has allowed AOR KIRAN KUMAR PATRA to file a SLP against R-2 TO R-7 who are Govt servants of Odisha in Supreme Court of India.

It is pertinent to mention that it is a rarest of rare case where two authorized AORs of Govt of Odisha are the opposite parties in a SLP and it needs to be published in journals where the law students should read about the miscarriage of justice along with the professional misconduct done willfully by the Govt of Odisha sponsored AORs.

It is obvious that both the AORs knew each other as they are authorized AORs of Govt of Odisha that they are involved in an illegal act as per the instruction of Govt of Odisha to face each other in the SLP which involves Govt of Odisha but none of them objected to this nor recused from doing so or raised objection in the appropriate forum; perhaps for some quid pro quo.

If AOR KIRAN KUMAR PATRA is the same person then he should be immediately suspended and license should be cancelled and it has to be brought to the kind notice of the Triple Bench who issued notice to me in a wrong name ie Jayanti Devi only because of AOR KIRAN KUMAR PATRA and Asst Registrar who did not verify the document before presenting the SLP before Triple Bench whereas it is primary duty of the registry to remove the defect and raise objection to the concerned AOR to rectify the same.

It did not happen in SLP CIVIL DIARY NO 21329 OF 2020 where I am Respondent no 1 whose WP (C)PIL 19827 of 2017 in Orissa High Court is challenged and with criminal intension my name was changed from Jayanti Das to Jayanti Devi and I was addressed as son of Kumuda Bandhu Das whereas he is my husband.

This shows the IQ level of both the AORs and Asst Registrar who handled SLP CIVIL DIARY NO 21329 OF 2020.

Again I am sending my earlier emails in the above matter in which no action has been taken against the culprits and they have made justice delivery system a mockery for personal gain with full support of Govt of Odisha.

I also want to inform you that the cadre officers of Govt of Odisha specifically Joint Secretary to CM Odisha has started addressing me as W/O LATE KUMUDA BANDHU DAS and stil it is continuing for last four months in a reply to my RTI application.

So this is strategy of Govt of Odisha to defame me in addressing in various names and relations and get away by saying typographical error.

Such thing is not expected from the Registry of Supreme Court and Govt of Odisha should be penalized for making mockery of judicial system by planting its two AORs both for the petitioner and respondents who are govt servants.

I request you to place my case before the Triple Bench who issued notice for sending me fresh notice in my correct name as per Orissa High Court order in the case WP (C)PIL 19827 of 2017 and place all my petitions /correspondence made with you in this regard.

The conduct of the AOR KIRAN KUMAR PATRA should be explained to the Hon'ble Triple Bench that how he has suppressed many facts and taken the Court for granted.

This should not repeat in future and exemplary cost should be imposed on both AOR KIRAN KUMAR PATRA and Govt of Odisha.
