Respected Sir

Please refer to the above mentioned letter where the Asst Registrar mentioned that Kiran Kumar Patra had filed an application for amendment of cause title with prayer to amend my name to Jayanti Das from Jayanti Devi.

You are requested to provide me a copy of the application for amendment of my name which I want to go through that on which grounds the advocate had made prayer to do the same.

It took approx two years to file the amendment petition by the advocate that too on several emails and letters to different authorities.

Filing of amendment petition is only one part of the story and it is a panic step by the advocate to whitewash all professional misconduct by him.

Please provide me a copy of issue notice or any communication made to the advocate to rectify the mistake by the registry of Supreme Court as all my communications were addressed to you and copy forwarded to other authorities but never to the said advocate.

I want to know how he came to know about my repeat complaints against him as I have never directly contacted him.

The registry of Supreme Court is silent about the professional misconduct of the Asst registrar who is equally responsible and negligent in removing defects from the SLP before placing it before Hon'ble Judges and willfully prolong the due process of law of inserting my correct name and address in the SLP.

You have also remained silent on the AOR issue of Kiran Kumar Patra for petitioner in SLP against GOVT OF ODISHA being the approved AOR of GOVT OF ODISHA drawing remuneration from GOVT OF ODISHA.

You let me know whether you have brought this issue of double crossing by Kiran Kumar Patra and playing double role to the knowledge of the Hon'ble Judges which is going to be heard by them in near future.

This is also negligence and professional misconduct of your registry where you have allowed the SLP to be heard and by suppressing many facts you and the concerned AOR managed to get a stay in my PIL where you willfully did not mention in your official note that Kiran Kumar Patra is an AOR of GOVT OF ODISHA who has filed this SLP for a private person against GOVT OF ODISHA.

In this case your registry, Kiran Kumar Patra and GOVT OF ODISHA are equally liable in this criminal attempt to damage the PIL by keeping the Hon'ble Judges in the dark to get a stay.

Provide me a copy of any action taken or any communication made with GOVT OF ODISHA by your registry regarding the double crossing by Kiran Kumar Patra who is AOR of GOVT OF ODISHA.

As a common man with little bit of legal knowledge I know that the registry is authorized office to file contempt of Court but in this case your registry is involved in contempt of Court where you are a party

and without your consent Kiran Kumar Patra would not have dared to take bench of three Judges for a ride in the first hearing.

If I analyze this case I can infer that your registry is involved in such type of criminal action where you dare to fool the Hon'ble Judges and your criminality is more dangerous for the society who shelter such type of double crossing AOR who eat from both the sides and thus it results in miscarriage of justice.

In comparison to your criminality that too in the top court of this country where people spend their lifetimes savings; I must say time has come for reforms starting from the registry to the SCAORA and BCI.

Under the circumstances this whole story of this SLP should come to the notice of Hon'ble Judges of this country through independent media as you are an interested party in this and you will never present my email to the Hon'ble Judges.

I expect a paragraph wise reply within seven days or I will take necessary steps to protect the Judiciary which is the lifeline of common man.
