It is pertinent to mention that I had sent several representations since 2020 till date for last four years in the above mentioned matter but nobody has acted upon the matter and allowed the mass slaughter of goats etc on public road in public view in Chhatar Jatra in Bhawanipatna Kalahandi every year and inspite of TOTAL BAN OF ANIMAL SACRIFICE BY ORISSA HIGH COURT IN WP (C) 19827 OF 2017 which was fraudulently stayed by AOR KIRAN KUMAR PATRA AOR OF GOVT OF ODISHA IN SUPREME COURT BY PREVIOUS GOVT IN THEIR LIST OF LAW OFFICERS.

It is unfortunate that although I had brought this matter to the notice of BCI, OSBC, AG NEW DELHI, AG CUTTACK, REGISTRY OF OHC, SCBA who are the competent authorities to take appropriate action against AOR KIRAN KUMAR PATRA AOR OF GOVT OF ODISHA IN SUPREME COURT THEY HAD REMAINED DEFUNCT AND ALLOWED AOR KIRAN KUMAR PATRA TO REMAIN IN THE PROFESSION WHICH WAS TO BE CANCELLED INSTANTLY FOR FOOLING JUDICIARY BY SUPPRESSION OF FACT AND MISDECLARATION ON AFFIDAVIT WITH THE HELP OF SC REGISTRY.

All the authorities mentioned above are capable of initiating disciplinary action against AOR KIRAN KUMAR PATRA FOR PROFESSIONAL MISCONDUCT AND TAKING OHC AND SC JUDGES FOR A RIDE AND DARING TO TELL LIES BEFORE BENCH OF THREE JUDGES INCLUDING CJI TO GET A STAY FOR VOTE BANK POLITICS IN WESTERN ODISHA BY THE PREVIOUS GOVT FOR LAST FOUR YEARS but they did not move an inch in this matter because of their brotherhood in ADVOCATE AND ADVOCATE ON RECORD FRATERNITY and it is also because of winning election in BCI and OSBC.

Your office is requested to take immediate and urgent steps to remove AOR KIRAN KUMAR PATRA FROM LIST OF LAW OFFICERS OF ODISHA GOVT, CANCEL HIS LICENSE TO PRACTISE AND INITIATE CRIMINAL ACTION AGAINST HIM FOR DAMAGING THE DIGNITY OF BOTH OHC AND SC WILLFULLY AND KNOWINGLY WITH A CRIMINAL INTENT.

The advocates and law officers are not above the law and constitution of India which they pretend to be because they are backed by a strong lobby of advocates and concerned registries.

AOR KIRAN KUMAR PATRA is able to do such type of criminal act only because of backing of SC REGISTRY as they are fully aware of such misconduct of the said person as I had sent email and speed post to CJI which was received by SC REGISTRY but they did not place email and speed post before CJI as they are party to this crime of fooling judiciary for their personal benefit and there must be quid pro quo because there is no free lunch.

Time has come to act on this issue to protect the dignity of judiciary as such type of advocates and REGISTRY destroy the most beautiful and effective orders of HIGH COURTS as TOTAL BAN OF ANIMAL SACRIFICE IN CHATAR JATRA BY ORISSA HIGH COURT IN WP (C) 19827 OF 2017 by bringing fraudulent stay in SC in connivance with the registry of SC.

If no action is taken and such types of acts of AOR and REGISTRY are allowed in SC and the common man has no direct access to CJI then the only path left is social media.
