**SUBJECT- OPEN AIR MUTTON SHOPS IN CUTTACK DISPLAYING THE DEAD BODY OF THE ANIMAL AND

No action has been taken deliberately from every quarter after repeat reminders and still the menace of killing the animals and birds by road side in every gali of Cuttack and above all small children of approx 5 to 6 years are being trained in public view by their parents and uncle how to catch and kill so that the FEAR OF BLOOD goes and insensitivity towards brutal killing increases from childhood at home and after being grown up they are fully trained butchers.

Now it is seen that small calves and big male calves are tied next to the slaughter house operated from residence in residential area specifically in Sheikh bazaar and prajatantra office chandni chowk Cuttack and there is serious apprehension of cow slaughter going on in these areas and it is in the knowledge of local PS which is dangerous for the society as law enforcement agencies are part of the crime.

Please refer to my email dated 20 02 2025 and 22 03 2025 in the above matter and it is quite unfortunate that you are silent and allow the illegal mutton shops to be fully aware that your UPD ACT does not permit this.

You do witch hunt on the poor vegetable vendors in the same area where the mutton shops are operational and do not allow in the name of UPD ACT but the dead body of the animal and bird in open by the side of the public road visible clearly are allowed right in front of the residence of sitting judges, retired judges and above all the executive magistrate's office in stadium road.

So it clearly proves that you have consent for the above mentioned activity going on in Cuttack in full swing and fully responsible for the trauma caused on daily basis to the people and if something goes wrong in physical and mental health you should be charged personally for ABETMENT TO CRIME because you are responsible officially for such type of irregularity and violation of ACT which you could have prevented as it is in your domain.
