**TO REGISTER A COMPLAINT CASE AGAINST PIO OSBC CUTTACK FOR NOT REPLYING MY RTI DATED 08 02 2023 TILL DATE**

I had filed a RTI with Bar Council of India New Delhi to provide copy of ATR against Kiran Kumar Patra AOR of Odisha Govt in Supreme Court who had filed a fraudulent SLP in Supreme Court against me and Odisha Govt to bring a stay on Orissa High Court order where a complete ban was imposed on mass animal slaughter in Chhatar Jatra Bhawanipatna.

It is pertinent to mention that the said AOR being a practicing advocate on record in Supreme Court comes directly under BCI for any of his professional misconduct but BCI instead of taking any action for last six years sent the RTI application to OSBC CUTTACK on 25 03 2023 vide letter no 186 on the plea that "Kiran Kumar Patra AOR of Odisha Govt in Supreme Court" seems to be enrolled with OSBC and the petitioner ie myself has some grievance against the said AOR.

It is quite disgusting and disgraceful to see the competence level of PIO BCI to interpret a heinous professional misconduct where Kiran Kumar Patra AOR of Odisha Govt in Supreme Court had suppressed the fact before 3 judges bench including CJI that he had filed the SLP for stay on Orissa High Court order where a complete ban was imposed on mass animal slaughter in Chhatar Jatra Bhawanipatna being a AOR of Odisha Govt in Supreme Court in Odisha Govt's payroll against Odisha Govt.

It is duty of BCI to take action suo motu against Kiran Kumar Patra AOR of Odisha Govt in Supreme Court but it referred the case to OSBC on a flimsy ground and OSBC being two steps ahead in protecting their fellow brother advocate is sitting on the RTI since 25 03 2023 till date without a single correspondence which is approx more than two years and so fine should be imposed @ Rs 250 per day multiplied by 365 days multiplied by 2 years.
