It is unfortunate that there is pin drop silence in all the quarters to whom I had sent my representation to activate ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY although it was initiated and inaugurated by CJI Shri Deepak Mishra several years back for the benefit of MIDDLE INCOME GROUP of Odisha.

The above mentioned society was not activated properly and its website was remaining non operational for years in the internet and required information was not uploaded in the website as it is done in case of JHARKHAND HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY AND PATNA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY (Copy enclosed) and I am unable to see the

full fledged website of ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY as it is visible in the above-mentioned two high courts and if you have other links to approach ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY then let me know as it is for the benefit of the MIDDLE INCOME GROUP of Odisha.

You are required to provide me the reason why it is non functional for 9 years as it appears from the website of ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY and it does not have its email id except ORISSA HIGH COURT contact number and email id which is totally different matter and ORISSA STATE LEGAL SERVICES AUTHORITY is also a state funded platform for ration card holders which has nothing to do with ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY which is an independent body funded by its executive committee members and self financed by the litigants and the crux of the story is MIDDLE INCOME GROUP LEGAL AID SOCIETY in all the high courts are headed by the Chief Justice of the concerned High Court as Patron in Chief and the Advocate enrolled in the panel are directly answerable for their negligence and can be removed on complaint and so there is check and balance and above all the fees are fixed and paid in white and the negligent advocate's name can be struck of and he has to refund the fees.

There cannot be a more favorable and golden opportunity for a client belonging to MIDDLE INCOME GROUP than this to avail the legal service in a transparent manner under the patronage of the Chief Justice of the concerned High Court.

You are required to provide me the information regarding the list of Advocates in the panel and the total number of clients who have availed the service in last 9 years from ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY till date.

I want to file WRIT petition through this society in the matter of DISCRETIONARY QUOTA LAND ALLOTMENT IN ODISHA and Supreme Court ORDER DATED 25 11 2024 quashing similar land allotment in Telangana in already in public domain.(copy enclosed)

I want to file WRIT petition through this society in the matter of AOR KIRAN KUMAR PATRA OF ODISHA GOVT IN SUPREME COURT who filed SLP against ODISHA GOVT BEING AOR of Odisha Govt and brought fraudulent stay on the OHC ORDER in Manikeswari PIL by suppression of fact before the bench of CJI and two other Hon'ble judges which is a crime against topmost judiciary including OHC where ODISHA GOVT is a party as it has protected the AOR since 2020 till date in spite of my several complaints to Odisha Govt.

No advocate is willing to take these two matters because of their strong lobby.

If I will not get any relief in the above matter from your office by providing the details sought, activated website of ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY in the light of JHARKHAND and email id to contact the Secretary of ORISSA HIGH COURT MIDDLE INCOME GROUP LEGAL AID SOCIETY then I will prefer other state which has this facility as they also have the JURISDICTION as my content pertains to dignity of Supreme Court and similar land scam in Telangana and corruption is an universal matter and not in national interest and so anybody from any state can intervene for protecting the national interest.
