**SUBJECT- IRREGULARITIES AND MISCONDUCT OF KIRAN KUMAR PATRA AOR OF ODISHA GOVT IN SUPREME COURT IN COLLUSION WITH REGISTRY OF SUPREME COURT**

Please refer to my EMAIL DATED 23 09 2024 TO CMO ODISHA REGARDING FRAUDULENT STAY BY KIRAN KUMAR PATRA AOR OF GOVT OF ODISHA IN SUPREME COURT BY THE PREVIOUS GOVT ON WP (C ) 19827 OF 2017 OF HON'BLE HIGH COURT OF ORISSA THROUGH SLP (CIVIL) DIARY NO.21329 OF 2020 and it is unfortunate that although the Govt of Odisha has changed and approx 9 months have passed no steps have been taken by the new Govt against the said KIRAN KUMAR PATRA AOR OF ODISHA GOVT IN SUPREME COURT.(copy enclosed)

It is a crime against judiciary where the AOR in connivance with the Govt and the registry of Supreme Court where a fraudulent stay has been taken on the order of Orissa High Court where there was a complete ban on animal slaughter in public view on public road in Chhatar Jatra Bhawanipatna by suppressing the fact that KIRAN KUMAR PATRA was on payroll of Odisha Govt when he filed the SLP to bring the stay against me and the top officials of Odisha Govt before the bench of CJI and two other lordships. The said KIRAN KUMAR PATRA had willfully addressed me as JAYANTI DEVI instead of my correct name JAYANTI DAS mentioned in my PIL so that due to wrong name I cannot proceed to defend and after repeat reminders to registry of Supreme Court it was corrected in the court of a single judge of Supreme Court and there also KIRAN KUMAR PATRA had suppressed the fact that he was on the payroll of Odisha Govt when he filed the SLP to bring the stay against me and the top officials of Odisha Govt before the bench of CJI and two other lordships for the SECOND TIME which proves he is a habitual offender and it is in the knowledge of registry of Supreme Court and it is a dangerous game where the AOR and Registry of Supreme Court are partners in this foul play being the part and parcel of the justice delivery system of the top court of the country.

It is quite unfortunate and disgraceful that the Odisha Govt is silent on this particular issue for vote bank politics at the cost of dignity of the higher judiciary like OHC and SC by playing politics.

Time has come that SUCH TYPE OF AOR SHOULD BE PUNISHED CRIMINALLY AND EXEMPLARY FINE SHOULD BE IMPOSED ON STATE GOVT AND SCAORA SHOULD BE SCRAPPED WITH IMMEDIATE EFFECT if they are not able to handle such type of AOR like KIRAN KUMAR PATRA who are bringing mafia culture in judiciary where they dare to fool the CJI in connivance with Registry of Supreme Court and there should be a press release by SCAORA about their ATR and BCI and OSBC should be held responsible criminally for encouraging such type of advocates who give a damn to higher judiciary being fully aware of the fact through repeat email.

The system is taking benefit of its own network where an advocate has to go against another brother advocate to bring the loopholes to the notice of the judiciary which is not possible because of conflict of interest and there is no direct email or contact address of the office of judges as all correspondence has to go through the scanner of the concerned registry who is party to this type of fraud going on in the justice delivery system and definitely it will not reach the judges and so both ADVOCATE and REGISTRY are overconfident of their foul play.

IT IS HIGH TIME THAT THE OFFICE OF JUDGES SHOULD BE IN DIRECT CONTACT WITH THE CITIZENS OF THE COUNTRY THROUGH THEIR OWN EMAIL ID OR ELSE THE DIGNITY OF THE JUDICIARY WILL BE ERASED SLOWLY WHICH HAS ALREADY STARTED BY NONE OTHER THAN THEIR OWN FRATERNITY LIKE AOR, REGISTRY AND IT IS MORE DANGEROUS IF SUCH PEOPLE BECOME JUDGES TO DECIDE THE FATE OF THE COMMON MAN.
