Most respectfully I want to inform the Hon'ble Supreme Court that in spite of my constant attempt to approach your lordship through speed post and email I have failed miserably to implement the BAN ORDER of ORISSA HIGH COURT ORDER IN WP (C) 19827 OF 2017 in Chhatar Jatra Bhawanipatna Odisha as the mass animal sacrifice in public view in public road with the consent of DM Kalahandi and SP Kalahandi along with DIG SWR and DGP Odisha who are the necessary parties in the SLP mentioned above and represented through AOR Shovan Misra of Odisha Govt in SC where the SLP was filed AGAINST GOVT OF ODISHA by his colleague AOR Kiran Kumar Patra of Odisha Govt in SC.

The occurrence of the incident of mass animal sacrifice in public view on a public road banned by Orissa High Court was reported by local electronic media on 30 09 2025.

This particular incident shows that the STRUCTURE OF THE CONSTITUTION HAS COLLAPSED IN ODISHA where the GOVT TRIES TO MAKE THE JUDICIARY AND INDIAN CONSTITUTION DEFUNCT BY ITS OWN AORS IN SC IN COLLUSION WITH THE REGISTRY OF SC and if it happens then no role of High Court exists as taxpayer's money is spent on AOR and individuals cannot fight against Government sponsored AORs and no advocate is willing to take up the case because of the AORs and the SC Registry.

The BCI and OSBC have become defunct to enjoy their position and power and decided not to get their hands dirty in such a controversial issue where it is against their own fraternity.

The SC administration has dared to block my speed posts sent to Hon'ble CJI and other Hon'ble Judge sent on 10 09 2025 vide SPEED POST NOS EO858420365IN AND EO858420374IN and duly delivered in their respective addresses and it is assumed that they did not reach the Hon'ble judges and the proof is the occurrence of the incident of mass animal sacrifice in public view on public road banned by Orissa High Court is reported by local electronic media on 30 09 2025.

The Govt of Odisha has been informed about the enquiry by office of CJI in this matter repeatedly still the Govt of Odisha has dared to allow the mass sacrifice only because of DISCRETIONARY QUOTA ALLOTMENT OF GOVT LAND BY HUD MINISTERS TO IAS IPS AND JUDGES SINCE 1995 TO 2011 IN ODISHA.

Under the circumstances the Hon'ble Judges are requested to suggest the citizens of this country to approach which forum to get justice and to ensure that their fundamental rights are protected if such kind of operations of killing justice delivery system is conducted through the AOR of SC in connivance with registry of SC where the funding is made from the taxpayer's money of the state and simultaneously only one branch of the constitution is surviving ie Political Executive.
