WPC PIL 8860/2019 JAYANTI DAS VS STATE OF ORISSA-

- 1) seeking direction to check mismanagement and inaction in the field of essential services like power, water, telecommunication and essential items like diesel, kerosene and gas
- 2) seeking direction to constitute independent committee of judicial officers/practitioners to regulate the implementation, restoration and distribution and the expenditure projected
- 3) seeking direction to state government to make formal request to the central government to declare cyclone FONI as national disaster
- 4) seeking direction to central government to deploy armed forces to restore the damages caused in cyclone FONI
- 5) seeking direction for compensation of Rs 1 crore to the family of deceased and Rs 25 lakhs to the injured in cyclone FONI
- 6) seeking direction to charge with 304 IPC (punishment for culpable homicide against the government officials who are responsible for death of 41 persons in cyclone FONI)
- 7) seeking direction to stop black marketing of essential services and commodities due to failure of administration

The PIL was filed on 9/5/2019 when the state and central elections were just over and the fate of politicians were sealed in EVMs. The announcement of result was 15 days ahead when the cyclone FONI hit Odisha.

There were CARETAKER GOVERNMENTs in both centre and state and no political party was going to lose / gain if they did not perform their duty to the voters. Nobody cared for the misery of people hit by cyclone FONI. So the petitioner thought it proper in the interest of people of Odisha who were suffering a lot to bring it to the kind notice of the court for immediate /instant relief by court intervention in such a CONSTITUTIONAL CRISIS where the people did not know whom to approach.
